

2025 Vicrez Multi-Winner Mega Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT ENHANCE THE CHANCE OF WINNING A PRIZE.

Eligibility:

This sweepstakes is open to legal residents of the United States, District of Columbia, and Canada who are age 18 or older at the time of entry, excluding residents of Florida, New York, Rhode Island, and Quebec.
